1. Eligibility

Participants must:

- Provide accurate registration details.
- Submit all mandatory documents.
- Meet the health and eligibility criteria prescribed by Global Yoga Records Council.

2. Registration

Registration is confirmed only after:

- Submission of all required documents.
 - Successful verification.
 - Payment of applicable registration fees.
 - Approval by Global Yoga Records Council.

3. Required Documentation

Participants may be required to submit:

- Application Form
- Government ID

4. Participant Responsibilities

5. Organizer Responsibilities

- Provide photographic and video evidence.
- Submit all required witness and adjudicator statements.
- Follow all operational guidelines issued by Global Yoga Records Council.

6. Evidence Requirements

Global Yoga Records Council may require:

- Continuous video recording
- High-quality photographs
- Witness statements
- Adjudicator reports
- Timekeeper reports
- Attendance verification
- Third-party audit (where applicable)

Failure to provide acceptable evidence may result in rejection of the record.



7. Approval of Records

Global Yoga Records Council reserves the sole authority to:

- Verify evidence
- Approve or reject record attempts
- Request additional evidence
- Modify record categories as per the final performance
- Reassess submissions where necessary

The decision of the Record Council shall be final.

8. Certificates

Certificates are generally issued within **21 working days** after successful attempt verification. Name corrections requested after certificate issuance may attract administrative charges.
